BRB formed for interior wall in Influent Pump Sta. south chamber, walkway at north end of Process Train 42, and gooseneck vents at Influent Pump Sta. & Return Sludge Pump Sta. valve vaults. BRB backfilled various structures including Water Supply Tank foundation and attempted to dry soils to get acceptable compaction. BRB placed concrete for Influent Pump Sta. interior wall in south chamber. BRB hydro-tested Water Supply Tank fill pipe under the foundation. BRB assembled Clarifier 61 equipment. Harness Roofing installed fascia and gutters on Admin. Bldg. roof eve. Cornerstone Masonry laid block at Screen Bldg. Davis J D Steel tied reinforcing for Process Train walls. Evans Coatings sandblasted and painted clarifier equipment.

Friday, Mar 5, 2010

BRB hydro-tested overflow and effluent pipes under the foundation for Water Supply Tank. BRB assembled Clarifier 61 equipment. BRB spread and graded sand for Water Supply Tank base. BRB disked soil stockpile to dry material and backfilled at Control Bldg. #1, Control Bldg. #2, UV Disinfection structure, and Sludge Storage Basin. BRB formed around arch pipes at Grit Chambers. BRB formed for walkway at north end of Process Train 42. MCC installed conduit sleeves and anchor bolts in walkway. Davis J D Steel tied reinforcing for walkway. BRB placed concrete for walkway at north end of Process Train 42, for Process Train walls 78A & 82A, and for blockouts for gooseneck vents at Influent Pump Sta. valve vault and Return Sludge Pump Sta. valve vault. Harness Roofing installed fascia and gutters on Admin. Bldg. Cornerstone Masonry laid block at Screen Bldg. and has a crew cleaning exterior block on Admin. Bldg. Decco was going to asphalt parking lots north and south of Admin. Bldg. but the prime coat was still not cured and tracks on the paver tires.
